This email address will be used solely for Zoom meeting registration and meeting invitation purposes. The required information allows an invitation to be sent to you and provides a method to verify your HOA membership. Your meeting invitation will include a link to join the meeting, a meeting ID number, and a password. Please make note of the ID number and password; you will need them to sign in after you click on the meeting link OR when prompted after dialing in by telephone.

Your pre-registration deadline for this test meeting is no later than 7 pm, Friday, June 5, 2020. Your meeting invitation will be sent to you the day of the meeting. We suggest you visit zoom.us.com in advance of the meeting where you will find simple instructions that will allow
